Gist of Application for Fuel and Power Purchase Cost Adjustment and Annual Performance Review for the year 2019 – 2020

1. West Bengal State Electricity Distribution Company Limited (WBSEDCL) has submitted applications before the West Bengal Electricity Regulatory Commission (Commission) for Fuel and Power Purchase Cost Adjustment (FPPCA) for the year 2019 – 2020 on 26.10.2021 and Annual Performance Review (APR) for the year 2019 – 2020 on 24.11.2021. The FPPCA application has been admitted on 26.01.2022 in Case No. FPPCA - 103/21 – 22 and the APR application has been admitted on 21.01.2022 in Case No. APR – 90/21 – 22 by the Commission.
2. The gist of the FPPCA and APR applications is as follows:

The FPPCA application is for approval of net Fuel and Power Purchase Cost of Rs 1708154 lakh and the APR application is for approval of Rs 811044 lakh towards Net Fixed cost for the financial year 2019 – 2020. WBSEDCL accordingly seeks to recover net revenue shortfall of Rs. 348081 lakh for the year 2019 – 20.
