Gist of Application for Fuel and Power Purchase Cost Adjustment and Annual Performance Review for the year 2021 – 2022

1. West Bengal State Electricity Distribution Company Limited (WBSEDCL) has submitted applications before the West Bengal Electricity Regulatory Commission (Commission) for Fuel and Power Purchase Cost Adjustment (FPPCA) for the year 2021–22 on 18.11.2022 and Annual Performance Review (APR) for the year 2021–22 on 24.11.2022. The FPPCA application has been admitted on 29.11.2022 in Case No. FPPCA-116/22-23 and the APR application has been admitted on 06.12.2022 in Case No. APR-110/22-23 by the Commission.
2. The gist of the FPPCA and APR applications is as follows:
The FPPCA application is for approval of net Fuel and Power Purchase Cost of Rs. 1618439 lakh and the APR application is for approval of Rs. 972420 lakh towards Net Fixed cost for the financial year 2021–22. WBSEDCL accordingly seeks to recover net revenue shortfall of Rs. 273765 lakh for the year 2021–22.
