## Gist of Application for Fuel and Power Purchase Cost Adjustment and Annual Performance Review for the year 2020 – 2021

1. West Bengal State Electricity Distribution Company Limited (WBSEDCL) has submitted applications before the West Bengal Electricity Regulatory Commission (Commission) for Fuel and Power Purchase Cost Adjustment (FPPCA) for the year 2020 – 21 on 08.06.2022 and Annual Performance Review (APR) for the year 2020 – 21 on 28.07.2022. Subsequently, WBSEDCL has also submitted a supplementary petition to their FPPCA application on 28.07.2022. The FPPCA application has been admitted on 13.06.2022 in Case No. FPPCA - 110/22 – 23 and the APR application has been admitted on 02.08.2022 in Case No. APR – 104/22 – 23 by the Commission. The gist of the aforesaid applications was published by WBSEDCL on 23.08.2022. Now, consequent upon the direction given by the Commission vide order dated 21.09.2022 in Case No. OA-395/21-22, WBSEDCL has submitted a 2<sup>nd</sup> Supplementary petition to their FPPCA application on 21.10.2022 by modifying their claim of FPPCA. The supplementary petition has been admitted by the Commission on 12.12.2022 in Case No: FPPCA – 110/22-23 and APR-104/22-23.
2. The gist of the applications is as follows:

The FPPCA application is for approval of net Fuel and Power Purchase Cost of Rs 16,52,533 lakh and the APR application is for approval of Rs 10,85,637 lakh towards Net Fixed cost for the financial year 2020 – 21. WBSEDCL accordingly seeks to recover net revenue shortfall of Rs. 6,79,897 lakh for the year 2020 – 21.
3.
