<u>Subject:</u> Providing new service connection at the charging infrastructure for Electric Vehicles [EVs] set up by the various players under the licensed area of WBSEDCL

In order to foster the growth of use of the **Electric Vehicles [EV]** across the State, various EV charging networks/infrastructures are being set up by various stake holders.

These EV charging stations are usually housed at various Petrol Pumps, Shopping-Malls, Hotels, Private/Government lands/buildings or any other suitable locations for the convenience of the general public who are using the Electric Vehicles & usually other service connection(s) is/are already existent at those premises.

Following the various Government Policies, issued time to time for last couple of years or so, to provide affordable tariff chargeable from the EV Charging Station Operators/Owners the West Bengal State Electricity Regulatory Commission [WBERC] has already published single part "tariff" in the tariff order on 28.07.2022 as promotional tariff for the Electric Vehicle Charging Stations.

Of late we have received few representations from such applicants, that they are facing difficulties in getting separate electric service connections for setting up of Electric Vehicle charging stations as there is already other service connection exists in those premises.

Therefore, this is essential to clarify that new electric connection is one of the pre-requisites for setting up of the charging infrastructure of Electric Vehicles and for that purpose separate tariff-class has already been defined by WBERC and hence new separate electric connection shall have to be provided even in same location where already a service connection exists within stipulated time frame as laid down in SOP regulation [of WBERC] after completion of all the technical and commercial formalities as well adhering to the necessary safety aspects by the applicant (s), even there is/are other service connection exist (s) at the same premises/buildings.

All concerned are advised to adhere to the above guidelines.

This order takes immediate effect.
