Transformer of Capacity: 10/16/25/50/63/100/250/300/ 315/500/630 KVA with voltage class 11-6.6-6/0.433KV & 33/0.4 KV along with the corresponding extension of Validity Period of Bank Guarantee up to 31.03.2020 with a Claim Period of 6 (six) months thereafter.

Sir/ Madam,

Rate Contract Order was issued vide Memo No. as mentioned above for enlistment of Repairer for Repairing of Damaged and Defective Dist. Transformer of Capacity: 10/ 16/ 25/ 50/ 63/ 100/ 250/ 300/ 315/ 500/ 630 KVA with voltage class 11-6.6-6/0.433KV & 33/0.4 KV against Tender No. P- 43/2014-15/DTR/RC/PC-III opened on 10.04.2015 valid up to 30th Sep' 2017 (1st October' 2015 to 30th September 2017 for 2 years). Consequent upon roll out of GST from 01/07/2017, the above rate contract order was modified vide Office Order No.- 63 dated- 05/09/2017 of the undersigned. The validity of the said rate contract was also extended for a period of one year i.e. from 01/10/2017 to 30/09/2018 vide Memo No.- P&C/P-43/Validity Extension of RC for Repairing of DTR/195 dated- 25/09/2017 of the undersigned.

It has been proposed to extend the Validity Period of this Rate Contract Order further up to 31st Mar' 2019 with effect from 1st Oct' 2018, keeping all the terms and conditions with revised rates circulated in the GST regime unaltered.

You may be eligible and continue to perform as enlisted vender under this Rate Contract for this proposed extended period after submitting confirmation regarding your acceptance of validity extension as well as to agree to extend the validity of Bank Guarantee up to 31.03.2020 with a Claim Period of 6 (six) months thereafter and submit the same before expiry of existing validity i.e. before 30/09/2018.

Your confirmation towards acceptance of proposal for extension of validity of Rate Contract as well as the extension of the validity of Bank Guarantee or to retain the Earnest Money Cum Security Deposit in form of Bank Draft is required.

It may be stated that the above consent towards proposed extension of Rate Contract does not carry any commitment towards continuance of Rate Contract.
