

MOST RESPECTFULLY SHEWETH:

- The West Bengal State Electricity Distribution Company Limited, hereinafter referred to as "WBSEDCL" is a Distribution Licensee under Electricity Act, 2003 and engaged in the business of generation, distribution and supply of electricity.
- M/s Rashmi Cement Limited, a Public Limited company within the meaning of the Companies Act, 1956 and having its Registered Office at Jhargram, Dist-Paschim Medinipur, West Bengal (hereinafter referred to as "RCL)".
- That RCL is the generating company having a waste gas based power plant of capacity 18.0 MW at at Jitusole, Jhargram, Dist. Paschim Medinipur, West Bengal. (hereinafter specifically referred to as 'RCL Generating station") owned and operated

by RCL as a captive Generating Plant on the basis of its generation plan and in pursuance to the definition of captive Generating Plant of The Electricity Rule, 2005.

4. WBSEDCL and Rashmi Cement Limited entered into a Power Purchase Agreement (in short 'Principal Agreement') on 11.12.2010 for purchase of surplus power by WBSEDCL from its 18 MW waste gas based power plant at Jitusole, Jhargram, Dist. Paschim Medinipur, West Bengal for a period of five years.

5. The above PPA was approved by Hon'ble West Bengal Electricity Regulatory Commission (herein after to be referred as 'Commission') on13.01.2011

6. On expiry of Principal agreement, First Supplementary Agreement to the Principal agreement dated 11.12.2010 executed on 09.12.2016 by and between WBSEDCL and Rashmi Cement Limited to extend the contract period upto 09.01.2021.

That as per clause 16 of the Principal Agreement which was subsequently modified in clause no 2 of First Supplementary Agreement, both the parties agreed to extend the contract period further for a period of 5 years (upto 09/01/2026), on mutual consent of the parties, by executing the Second Supplementary Agreement on 28.06.2021. A copy of the executed Agreement is enclosed as Annexure-I.

This Second Supplementary Agreement to the Power Purchase Agreement (PPA) as executed on 11.12.2010 (herein referred as Principal Agreement) and subsequent First Supplementary Agreement dated 09.12.2016 is herewith signed between M/s RASHMI CEMENT LIMITED, a Public Limited Company within the meaning of the Companies. Act, 1956 and having its Registered Office at Jhargram, Dist. Paschim Medinipur, West Bengal hereinafter referred to as "RCL" (which expression shall, unless repugnant to the context or meaning thereof, include its successors and assigns) as the party of the First Part.

WEST BENGAL STATE ELECTRICITY DISTRIBUTION COMPANY LIMITED, a Govt. of West Bengal Enterprise, constituted under the Companies Act, 1956 having its Registered Office at Vidyut Bhavan, Block-DJ. Sector -II, Bidhannagar, Kolkata -700091, hereinafter referred to as "WBSEDCL"(which expressions shall unless repugnant to the context or meaning thereof include its successors and assigns) as party of the Second Part.

"RCL" and "WBSEDCL" are herein referred to individually as a "Party" and collectively as the "Parties".

WHEREAS Principal Agreement was executed on 11.12.2010 by & between RCL and WBSEDCL. The validity period of Principal Agreement expired on 00 of 2016 Subsequently First Supplementary Agreement is executed on 09.12.2016. The validity of First Supplementary Agreement has expired on 09.01.202*. As per clause 16 of the Principal Agreement both the parties agreed to extend the contract period touther, on mutual consent of the parties on following terms & conditions by oscuring this second Supplementary Agreement:

NOW THESE PRESENTS WITNESSETH and the parties herein duree as follows:

1. At the end of clause no. 2.1 of the Principle agreement dtd 26.05.2010, following table is inserted in the agreement as a tentative supply:-

- 2. After clause no. 6.4 of the Principle agreement dtd 26.05.2010following clause shall be inserted
 - (6.5) Tariff shall be subject to cap price of ₹2.04/KWH (1/3rd ₹2.55/KWH and 2/3rd ₹1.78/KWH) which is claimed by RCL in the bill for the month of February, 2021
- 3. After clause no.17.vi) of the Principle agreement dtd 26.05.2010, following clause shall be
 - vii) This agreement can be terminated by WBSEDCL under the reasons mentioned below:
 - PPA shall be terminated automatically if supply is discontinued by RCL for more than one year for any reason(s) whatsoever.
 - PPA will be terminated on issuance of order of the Commission for termination (b) of the agreement in case of any violation of grid discipline.

21. RPO compliance:

RCL has to comply the provisions of West Bengal Electricity Regulatory Commission (Cogeneration and generation of Electricity from Renewable Source of Energy (First Amendment) Regulation, 2020. RCL requires to submit quarterly report containing actual

consumption, energy sourced through open access / from captive plant, purchase / sourcing from renewable energy sources and solar & non-solar RPO compliance to the connected distribution licensee, i.e., WBSEDCL as per Regulation 3.10 of the Principal Regulation of West Bengal Electricity Regulatory Commission (Co-generation and generation of Electricity from Renewable Source of Energy (First Amendment) Regulation, 2020 3 20005

22. MISCELLANEOUS PROVISION:

Any matter not covered by the Power Purchase Agreement will be governed by the Electricity Act' 2003 and relevant Regulations of WBERC

23. The parties have mutually agreed that the period of this second Supplementary Agreement is extended upto 09.01.2026 for five years from 09.01.2021 subject to approval of WBERC. The terms of the Power Purchase Agreement may still be further extended as per mutual consent of the parties.

All other terms and conditions of the Principal Agreement dated 11.12.2010 and first Supplementary Agreement dtd 09.12.2016 will remain unchanged.

This Second Supplementary Agreement will be part and parcel of the Principal Agreement dated 11.12.2010 and first Supplementary Agreement.

EXTRACTS FROM THE MINUTES OF THE 96TH MEETING OF BOARD OF DIRECTORS OF WEST BENGAL STATE ELECTRICITY DISTRIBUTION COMPANY LIMITED HELD ON THURSDAY, 25TH MARCH, 2021

36. Approval for execution of Second Supplementary Agreement to the Power Purchase Agreement (PPA) (executed on 11th December, 2010) & First Supplementary Agreement (dated 09.12.2016) to be executed by and between Rashmi Cement Ltd. and West Bengal State Electricity Distribution Company Limited (WBSEDCL) for purchase of low cost surplus Power

Director (R&T) placed the details of the matter before the Board.

A Power Purchase Agreement was executed between M/S Rashmi Cement Limited and West Bengal State Electricity Distribution Company Ltd. on 11.12.2010 and subsequently, First Supplementary Agreement was executed on 09.12.2016. As per clause no. 16.3 of the WBERC, Second Supplementary Agreement was prepared to modify / add some clauses.

Advantages for purchasing this power are namely, Tariff would be subject to cap price of ₹2.04/KWH, there would be no transmission cost, low cost power and Medium term solution to reduce power shortage in the state. M/S Rashmi Cement Limited have given their consent on execution of Second Supplementary Agreement.

The Board discussed and observed that in view of Model Code of Conduct being enforced for West Bengal Legislative Assembly Elections, only In-principle approval may be accorded.

Thereafter the Board passed the following resolution:

"RESOLVED THAT In - Principle approval for execution of Second Supplementary Agreement to the Power Purchase Agreement (PPA) (as executed on 11th December, 2010) & First Supplementary Agreement dated 09.12.2016 by and between Rashmi Cement Ltd. and West Bengal State Electricity Distribution Company Limited (WBSEDCL) for purchase of low cost surplus Power of Rashmi Cement Ltd. by WBSEDCL for further period of 5years (extended upto 09.01.2026 for five years from 09.01.2021) as an energy efficient measure is hereby accorded by the Board."

"RESOLVED FURTHER THAT Chairman and Managing Director of the Company be and is hereby authorized to accept any change/modification in the clauses of the second supplementary agreement as may be suggested by the WBERC."
